

RULES AND REGULATIONS
14th ANNUAL ASHP CLINICAL SKILLS COMPETITION
SEMI-FINAL ROUND: SATURDAY, DECEMBER 5, 2009

Congratulations on winning your local competition! Please review the following information:

- Please place your personal belongings along the inside of the competition room. You may only bring writing utensils to your workstation.
- You have two hours to complete the written materials. You will receive notification when there are 60, 30, 15, and 5 minutes remaining.
- You may not ask any questions of the competition staff.
- Talking with other teams is not permitted and subject to disqualification.
- You may use the restroom, get refreshments and consult references without permission from the competition staff.
- You may not take anything from or bring anything into the room during competition hours.
- References may not be removed from the reference table. There is a 10-minute limit per time you visit the reference table. An AHFS Drug Information text (big red book) has been provided for your use at your workstation.
- Please work on your case at your assigned station only.
- The preliminary competition is a closed session. No visitors or guests are allowed in the room.
- You may take notes if you wish to prepare for the oral presentation on a blank piece of paper which will be provided for you. This will be collected with the rest of the competition materials at the end of your two hour competition time block. If your team advances to the final round, you will receive all written materials including your notes 15 minutes prior to your oral presentation for review.
- **At the conclusion of the two hours, please wait until someone checks your materials and dismisses you. Please turn in everything you received during the competition.**
- The finalist teams will be announced during the Student Programming on Sunday, December 6th between 8:00-9:20 a.m. in **Room 3201A, Murano, Level 3**, Venetian Conference Center.
- **The judges, case writers and competition coordinators will hold a debriefing session for all interested CSC participants.** This will include a review of the answer key and Q&A at the conclusion of the finalist presentations at 4:30 p.m. on Sunday, December 6th, in **Room 2102, Bellini, Level 2**, Venetian Conference Center. This session is designed to help you understand what the judges were looking for in the written and oral presentation portions of the competition.
- If you do not advance to the final round, you may pick up your case, forms, score sheet, and answer key at the conclusion of the final round on Sunday, December 6th at the 4:30 p.m. review session. All participants may pick up their cases starting Monday morning, Dec 7th, at ASHP's **Membership Information Center** located in the Venetian Foyer, Level 2, Venetian Conference Center.
- Please plan on joining everyone at the Student Reception on Sunday, December 6th, from 4:30-6:00 p.m. at the **Palazzo Ballroom E, Level 5**, Venetian Conference Center where the winners of the competition will be announced. Please arrive no later than **5:15pm**.
