If nominating a group, contact information will only be required for the group leader.*

2. Current professional position and institution for the nominee(s). *For the Board of Directors' Award of Excellence and the Chief Executive Officer's Award for Courageous Service, please also note the professional position of the nominee(s) at the time of the contribution or achievement.*
3. Brief explanation of your reasons for believing this individual (or group) should receive the specified award.
4. Resume or Curriculum Vitae (CV) for your nominee(s). If you are nominating a group, you will only be asked to upload a resume or CV for the group leader.

Selections will be made in January 2017. In some years, selections are not made for all awards.

# SELECT ASHP AWARDS AND HONORS

## A. Board of Directors' Award of Excellence

Established in 2005 as the successor to the ASHP Certificate of Appreciation, the ASHP Board of Directors' Award of Excellence recognizes contributions to excellence in pharmacy practice in acute and ambulatory care settings. The award, which is conferred at the discretion of the ASHP Board of Directors, may be presented annually at the ASHP Summer Meetings or other appropriate function. There is no limit to the number of awards that may be conferred each year.

The award is intended to recognize an individual or group of individuals for a recent, singular, nationally significant achievement or contribution that has advanced the ability of pharmacists who practice in acute and ambulatory care settings to serve the needs of patients. Pharmacists and non-pharmacists, regardless of practice area or ASHP membership status, are eligible.

Nominations should state:

- How the contribution or achievement advanced the ability of pharmacists in acute or ambulatory care settings to serve the needs of patients, and
- Why the contribution or achievement is of national significance.

Honorary members may vote or hold office if otherwise eligible for active membership. No dues shall be required of honorary members."

The award is intended to recognize an individual or group of individuals for specific incidents of inspiring, unselfish service under adverse conditions. Pharmacists and non-pharmacists, regardless of practice area or ASHP- membership status, are eligible.

**G. ASHP-ABHP Joint Leadership Award**

Established in 2009, the ASHP-ABHP Joint Leadership Award recognizes individuals who have demonstrated exceptional leadership in efforts to reduce racial and ethnic disparities in healthcare. The award, which is conferred at the discretion of ASHP and the ABHP Boards of Directors, may be given annually to one person and may be presented to the recipient at the ABHP Luncheon held on the Tuesday of the ASHP Midyear Clinical Meeting or other appropriate function.

Nominations should state how the nominee has demonstrated leadership in the reduction of racial and ethnic disparities in healthcare in one or more of the following areas:

- Increasing awareness of these disparities among healthcare providers, administrators, legislators, regulators, third-party payers, and the public;
- Promoting a more diverse and culturally competent healthcare workforce and environment;
- Ensuring effective communication with patients and among providers;
- Fostering consistent use of multidisciplinary teams and evidence-based guidelines for patient care;
- Collecting and reporting data on healthcare access, utilization, and outcomes by racial and ethnic minorities, and measuring progress toward reducing healthcare disparities; or
- Researching, identifying, and disseminating best practices for providing culturally competent care and reducing disparities in healthcare.
