Subject: Hurricane Maria Supply Update

Dear Valued Baxter Customer,

We're writing to provide you with an update regarding our recovery activities and the supply assessments underway in Puerto Rico following Hurricane Maria.

Our priority is to do all we can to ensure a consistent supply of products for the patients you serve and to minimize any disruption of service to your facility. While our sites sustained some damage, remediation activities have been underway and we've made good progress toward initiating production activities. In addition, we are examining all opportunities to leverage Baxter's global manufacturing network as we continue efforts to restore manufacturing operations in Puerto Rico.

As you know, Baxter took proactive measures to help sustain the supply of existing inventory when we placed the products manufactured in the Caribbean region on allocation. Please refer to our letter dated September 22, 2017.

As we continue our assessments, the projected supply of certain products requires us to adjust previously established allocations and to remove some products from the distributor/wholesaler channel for the foreseeable future. We are taking these proactive steps to responsibly manage and optimize inventory levels in order to serve our existing customers to the best of our ability. It will also prevent unusual and excessive purchasing, thus helping to support equitable product distribution.


The included list indicates which products will be removed from the channel and available only through direct purchase from Baxter, effective immediately. The table also indicates which product allocations are being adjusted.

Product allocation amounts are being recalculated for the attached products, based on your average monthly purchase history from March through August, 2017 – both directly from Baxter and as reported to Baxter by your distributor or wholesaler. The specific allocation amounts will be available from your Baxter sales representative or via your eServices account.

We regret this disruption to your daily operations and appreciate your patience as we reestablish our supply pipeline.
