## Busy Day Tool Kit Preceptor Instructions

Learner level: IPPE and APPE Students

**Estimated time to complete:** May take several hours/days and can be done intermittently while completing other assigned projects.

**Preceptor Instructions:** Provide students with a question pertaining to a recently updated or new federal pharmacy law (or general question pertaining to law). Inquire about what resources students are already familiar with to approach answering a law question. Give a brief overview of each resource students are familiar with and discuss further resources.

**Student Instructions:** Receive a question specific to federal pharmacy law. Determine how you would approach answering the question and what resources you would use to find the appropriate information. List any resources that you feel you are unfamiliar with to discuss further.

- 2. Orange Book: Approved Drug Products with Therapeutic Equivalence Evaluations – <u>Orange Book</u>

*Provides a unique search feature to determine therapeutic equivalence of generic medications.* 

- Variety of Search Options
  - o Proprietary Name, Active Ingredient or Application Number
  - Applicant (Company)
  - Dosage Form
  - Route of Administration
  - Patent Number
- "Additional information and resources for the Orange Book" (found at top of page)
  - Find Orange Book Publications
  - Additional Resources FAQ, additions/deletions, data files, etc.
- 3. Purple Book: Licensed Biological Products with Reference Product Exclusivity and Biosimilarity or Interchangeability Evaluations – <u>Purple Book</u>

Provides additional resources for background information related to biosimilar development, review, and approval.

- Available as PDF file
  - Product (Proper) Name
  - Proprietary Name
  - Date of Licensure
  - Interchangeable (I) / Biosimilar (B)
- Additional information on biosimilars (found on left side of page)
  - Biosimilar and Interchangeable Products
  - Biosimilar Development, Review, and Approval
  - Prescribing Biosimilar and Interchangeable Products
