Target Audience

This activity was planned to meet the educational needs of ambulatory care and community pharmacists who practice in states where oral contraceptive prescribing is possible. Pharmacists in other states looking to grow clinical pharmacy services and advocate for expanded roles for pharmacists will also benefit.

Activity Overview

As more individual states pass legislation allowing pharmacists to prescribe contraceptive agents, pharmacists in the community and ambulatory care settings must be prepared to properly assess and screen patients prior to contraceptive initiation, select the best product for individual patients, provide effective counseling, and make necessary adjustments when patients experience adverse effects and other challenges. During this activity, presenters will discuss advocacy considerations in expanding the pharmacist's role in oral contraceptive prescribing where it is not yet legal and share their experience in prescribing oral contraceptives.

- Describe advocacy considerations for expanding the pharmacist's role in oral contraceptive prescribing.
- Discuss the screening process of patients for eligibility of pharmacist-provided for oral contraceptives.
