### **December 19, 2014 Early Commitment Deadline**

The ASHP Resident Matching Program incorporates an Early Commitment Process, whereby a position in a PGY2 program can be committed to a current PGY1 resident within the same organization in advance of the matching process. Information on this Early Commitment Process is available from the Match web site at [www.natmatch.com/ashprmp](http://www.natmatch.com/ashprmp).

Please note: if you early commit to a current resident in your program and you originally signed up for PhORCAS, you must go into your PhORCAS selection portal and the residency program director needs to close your application deadline.

### **March 6, 2015**

This is the final date for submission of applicant and program Rank Order Lists.

**No Rank Order Lists or registrations can be accepted after this date.**

### **March 20, 2015**

Results of the Match are released to applicants and program directors by 12 noon Eastern Daylight Saving Time on this date.

### **March 20, 2015-April 19, 2015**

Program directors must send letters of confirmation of the Match result to matched applicants, who must sign and return the letters of confirmation. Unmatched applicants can see available programs and positions participating in the post-match process 12:00 pm EST.

### **Post-match Scramble:**

The PhORCAS portal will be open for unmatched applicants and for those programs with unmatched positions still seeking to fill them.

**Monday March 23**, applicants can begin applying to programs with open residency positions in PhORCAS. Programs gain access to unmatched applicants list.

### **Monday, March 30**

Program directors may begin to make offers to applicants to unmatched positions. (The Commission on Credentialing is recommending a one week moratorium on making offers to ensure that all parties have had time to consider their post-match options.)

**May 31**, PhORCAS officially closes for the post-match process.

As above, program directors must send letters of confirmation to their matched applicants.

### Which One to Use and When

At their September 2014 meetings, the ASHP Commission on Credentialing and ASHP Board of Directors approved a new *ASHP Accreditation Standard for Postgraduate Year One (PGY1) Pharmacy Residency Programs*. This new accreditation standard will replace the current 2005 version of the PGY1 accreditation standard for all programs on July 1, 2016.

She completed an ASHP accredited Specialty Pharmacy Residency in Geriatrics at the VA Medical Center in Durham, North Carolina in cooperation with the Duke Center for Aging. ASHP seeks to engage members in an open forum to discuss future needs for residency training and Board certification. As we move forward towards achieving provider status and new health care models emerge we think it is time to engage in a discussion of the future role of residency training and board certification. This session will explore the evolution of specialty credentials and their relationship to residency training and pharmacy education. We will also examine work currently underway regarding the framework around specialty credentials and discuss the future of advanced specialty training and seek members’ input on the need for a broader consensus conference on the future of residency training.

## ResiTrak™ Corner and the new PharmAcademic™ System

ASHP recently announced the decision to select PharmAcademic™, a product of the McCreadie Group, as the new system that will be used for the new PGY1 Pharmacy Residency Accreditation Standard and educational Competency Areas, Goals, and Objectives. The McCreadie Group will maintain ResiTrak™ for all other residency programs until new accreditation standards and educational Competency Areas, Goals, and Objectives have been completed.

### Frequently Asked Questions from the McCreadie Group: Using PharmAcademic™ for ASHP-Accredited Residencies

#### 1) What is PharmAcademic™?

PharmAcademic™ is a tool used by leading colleges of pharmacy to manage curricular outcomes, assessments and experiential education. PharmAcademic™ is closely interfaced to PharmPortfolio™, an electronic learning and showcase portfolio already accessible to residents. PharmAcademic™ is a product of the McCreadie Group who has produced and supported ResiTrak™ since its inception in 2007.

#### 2) Why are we going to use PharmAcademic™ instead of ResiTrak™?

There are many reasons why we will be transitioning ResiTrak programs into PharmAcademic™:

- There is a significant overlap in the types of things that are tracked and managed in colleges of pharmacy and residency programs.
- PharmAcademic™ is built on a more modern software platform that is mobile-friendly. This will allow much better use in residency programs on tablets or other mobile devices.
- Preceptors will use one tool instead of two for residents and students of schools using PharmAcademic™.
- It allows us to focus our engineering and support resources on one product instead of two

#### 3) When can I start using PharmAcademic™ to set up my Program?

We will have the software ready in the spring of 2015. More communication will be forthcoming as dates are finalized.

#### 4) What about PGY2 Programs?

At this time, only the new standard for PGY1 pharmacy programs has been approved. PGY2 programs and other PGY1 programs will continue to use ResiTrak™ until migrated to PharmAcademic™.

#### 5) Will I lose my information in ResiTrak™?

No. We will provide mechanisms for access to the historical information needed for accreditation purposes.

#### 6) Can I continue to use ResiTrak but with the new standard?

No. The new standard will not be built into ResiTrak™.

#### 7) Will I have to set up my Program again in PharmAcademic™?

There will be some setup needs as the standard has changed including all new competency areas, goals and objectives. We will work with programs to copy certain elements (e.g. Learning Experiences) to PharmAcademic™ to minimize setup effort.

#### 8) What are some of the new things that we don't currently have in ResiTrak™?

PharmAcademic™ will meet the new residency standard and offer support for the following:

- RPD designees and other residency roles
- Multiple preceptors and preceptors in training support including in evaluations
- Ability to associate objectives with a learning experience instead of just goals
- Activity tracking within learning experiences
- Tools for tracking preceptor development
- More flexibility in customizing and scheduling evaluations
- More flexibility in developing and delivering formative feedback
- Tools to maintain the residency binder in an electronic format Not all these improvements will be available by the spring of 2015.

9) Will there be training for PharmAcademic?

Yes. There will be multiple training opportunities and materials available. This will include written materials, recorded videos and webinar-style presentations.
