New Pharmacy Technician Accreditation Commission (PTAC)

ASHP-ACPE Collaboration Will Advance Quality of Technician Education, Training

The American Society of Health-System Pharmacists (ASHP) and the Accreditation Council for Pharmacy Education (ACPE) are pleased to announce their collaboration to accredit pharmacy technician education and training programs, beginning in late 2014. The collaboration will result in the creation of the Pharmacy Technician Accreditation Commission (PTAC), which will be tasked with assuring and advancing the quality of pharmacy technician education and training programs.

The PTAC will conduct document reviews and site surveys and advise the ASHP and ACPE boards of directors, which will then agree on final accreditation actions. The establishment of the PTAC expands upon ASHP's 31-year history as the national accrediting body for pharmacy technician training programs and incorporates ACPE's expertise in the accreditation of educational programs.

New ASHP Accreditation Standard for Pharmacy Technician Training Programs: Implementation Timeline Information

The new *ASHP Accreditation Standard for Pharmacy Technician Training Programs* is now available on the ASHP website:

The new Standard was developed by the ASHP Commission on Credentialing in conjunction with the Pharmacy Technician Advisory Group and was approved by the ASHP Board of Directors on April 12, 2013.

This version supersedes the *ASHP Accreditation Standard for Pharmacy Technician Programs*, approved September 27, 2002.

For existing programs, this revision of the accreditation standard takes effect January 15, 2015. Until that time the current Standard, which was approved September 27, 2002, remains in effect. Existing programs are free to convert to the new Standard any time after January 1, 2014.

Any new programs starting after January 1, 2014 must begin by using the new Standard.

A new *Guidance Document* is also posted. The *Guidance Document* is not the Standard but gives additional explanations and it provides examples of evidence that programs can use to show compliance with the Standards. Access it here:

By 2020, PTCB will require candidates for initial PTCB certification to successfully complete an American Society of Health-System Pharmacists (ASHP)-accredited education program. ASHP-accredited programs include didactic course work and practical experience, thereby providing well-rounded training for technicians.

PTCB To Introduce Updated Certification Exam on November 1 (8/13)

The Pharmacy Technician Certification Board (PTCB) will introduce its updated Pharmacy Technician Certification Exam (PTCE) on November 1. The updated exam measures the knowledge pharmacy technicians need to effectively support pharmacists and advance patient safety in today's pharmacies. Candidates who apply for PTCB certification before November 1 will be given the current PTCE, and those who apply on or after November 1 will take [the updated exam](#).

The total number of certifications granted by the Pharmacy Technician Certification Board (PTCB) recently eclipsed half a million, totaling 503,620 as of June 30, 2013. In 2012 alone, 39,729 candidates passed the Pharmacy Technician Certification Exam (PTCE).
