

New ASHP Website - Navigation Tips


ASHP's new website was launched a few months ago with dynamic information and a new navigation system. The following information highlights some key features of the new format and provides tips for navigation to the most commonly sought information. Once you become familiar with the website content, you can customize your view to go directly to the information that is most useful to you.

The main page is organized in 6 main content areas. For quick access to information related to pharmacy technician program accreditation, follow these steps:

- Click on the **VIEW ALL** arrow under the **PROFESSIONAL DEVELOPMENT** section on the home page - this will expand

the menu to show all **PROFESSIONAL DEVELOPMENT** resources

- Next, click on **Technician Program Accreditation** to expand the menu. Options from this menu include information on starting a pharmacy technician program, accreditation standards and regulations, and other helpful resources and tools.

PTAC Biannual Meeting

May 9-10, 2017 Bethesda, MD

PTAC held its biannual meeting May 9-10, 2017 in Bethesda, Maryland. In addition to reviewing survey reports and applications for new program directors, commission members also reviewed new draft regulations for pharmacy technician training program accreditation which were presented to the boards of directors of ASHP and ACPE following the next PTAC meeting which will be held October 25-26, 2017 at ASHP headquarters in Bethesda, Maryland.

Program Accreditation/Reaccreditation

The Commission reviewed survey site visit reports for 14 new programs and 14 previously accredited programs seeking reaccreditation. Midterm reports (27) and special case reports (29) were also reviewed along with 13 applications for new program directors. As of the date of the meeting, 262 programs are in the accreditation process which includes accredited programs and programs in candidate status.

Congratulations to the following programs that were had their onsite visit for this meeting and were granted initial accreditation or reaccreditation meeting the accreditation standards for pharmacy technician training programs!

Updated Regulations for Pharmacy Technician Education Approved

The regulations for pharmacy technician training program accreditation were updated to reflect current practices that changed since the last revision. The following listing illustrates the major changes (some editorial/grammatical changes were implemented that aren't on the list below) from the current regulation document that is being used:

Key Changes:

1. The introduction has been written to reflect the collaboration between ASHP and ACPE in the accreditation of pharmacy technician education and training programs.
2. Definitions have been developed for the following terms: accredited entity, conditional accreditation, program management site, PTAC, substantive change, resource; withdrawn and withhold with respect to the accreditation of pharmacy technician education and training programs.
3. The authority for accreditation was updated to reflect the PTAC's governance by both Boards of Directors.
4. The initial application procedures were revised to reflect the new address of ASHP and the role of the Vice President of the Accreditation Services Office (ASO), as opposed to the former designation of Director of the Accreditation Services Division.
5. Everywhere (except when items are to be sent in to the ASO) ASHP is listed, it has been modified to ASHP/ACPE.
6. Description has been added under the accreditation section to reflect that surveys will be accommodated in an expeditious fashion for states that have new laws requiring the technician training programs to be accredited within a short period of time.
7. More description was provided under the reaccreditation section to describe why additional site surveys may be warranted if substantial changes occur within a program. Other changes in the section include removal of the example of the length of accreditation that can be granted if not granted full cycle.
8. The withdrawal of accreditation section now includes a statement that to maintain accreditation, programs must comply with all requests from ASHP/ACPE for reports

(e.g., statistical information about program graduates). There is also a statement indicating that program failure to submit reports as requested may result in withdrawal of accreditation or in a notice of intent to withdraw accreditation.

9. The construct of the appeal board was modified to reflect the collaboration between ASHP and ACPE.


Moné joined Cardinal Health in May 2006 as director of regulatory compliance for Medicine Shoppe International (MSI) where he was responsible for licensing and registration of franchise and company-owned pharmacies, educating MSI pharmacies on state and federal law and regulatory changes, and he also developed a regulatory compliance program that provides an early warning system to potential compliance issues.

As a licensed pharmacist and lawyer, Moné has served in a variety of roles in private and public practice of law and pharmacy prior to joining Cardinal Health. From 1996 to 2004, he led the Kentucky Board of Pharmacy where he developed statewide public health policy and was in charge of all investigative efforts for the agency. He also served as an attorney for the Florida Board of Pharmacy. In addition, Moné has served as an assistant attorney general in Florida as the general counsel for the Boards of Chiropractic, Osteopathic Medicine, Veterinary Medicine and Pilot Commissioners. In private practice, he served as both legal counsel representing clients in federal regulatory matters, as well as a pharmacist in both the hospital and independent retail pharmacy settings. Moné has also published multiple works on the topics of pharmacy and law. He attended the University of Florida where he received both his Juris Doctorate and Bachelor of Science in pharmacy.

Moné has held leadership roles within many industry associations, including the National Association of Boards of Pharmacy, Ohio State Board of Pharmacy, where he currently serves as its President, Accreditation Council for Pharmacy Education, U.S. Pharmacopeia, American Pharmacists Association and Florida Pharmacy Association. He also served on the Kentucky Governor's Task Force on Controlled Substance Abuse and the Attorney General's Task force to develop KASPER, the Kentucky All Schedule Prescription Electronic Reporting System, which tracks controlled substance prescriptions dispensed within the state to stop abuse, misuse, diversion and illegal sale of prescription drugs.

Pharmacy Technician Stakeholders Consensus Conference February 14-16, 2017

In pursuit of a path toward resolving unsettled issues related to pharmacy technicians, the Pharmacy Technician Certification Board (PTCB) sponsored a stakeholder consensus conference on February 14-16, 2017, in Irving, Texas. Planned in collaboration with the Accreditation Council for Pharmacy Education (ACPE) and the



American Society of Health-System Pharmacists (ASHP) and under the guidance of an advisory committee representing all major branches of pharmacy, this invitational event yielded important recommendations concerning the definition, education, entry-level requirements, advanced practice, certification, and regulation of pharmacy technicians.

The 89 invited [participants](#) in the conference included pharmacists and technicians from various types of practice and educational settings, pharmacy association executives, regulators, and representatives of the general public. Approximately 350 individuals participated remotely in the plenary sessions of the conference through a Web link.

KEY POINTS

- A national consensus conference engaged all sectors of pharmacy in identifying points of agreement regarding entry-level requirements for pharmacy technicians.
- State variability in the regulation of pharmacy technicians poses risks for patients and the profession of pharmacy.
- Conferees were polled on their extent of agreement or disagreement with 59 statements related to unsettled pharmacy technician issues.
- Conferees agreed that a task analysis should be the basis for accredited technician education, technician certification, and state regulation of technicians.
- Conferees recommended the creation of a broad coalition to pursue the recommendations of the conference.

Note: Following the conclusion of the Pharmacy Technician Stakeholders Consensus Conference and at the May PTAC meeting, PTAC members voted to recommend a timeline for development, review, and approval of new pharmacy technician accreditation standards by the Boards of Directors of ASHP and ACPE by June 2018. This action was voted on and approved by both the ASHP and ACPE Board of Directors at their June meetings.

Accreditation Survey Analysis: Most Commonly Cited Standards

A recent analysis of survey reports reviewed at the October 2016 and May 2017 PTAC meetings revealed the most commonly cited standards found during accreditation visits. The table below shows standards that were cited greater than 10 times. PTAC recommends that programs utilize the Guidance Document to review information about how the standards are interpreted and how they will be surveyed. The Guidance document can be found [here](#).
